Retirement Resolution

Maribeth "Mimi" J. Loose retires from the Department of Natural Resources on August 24th, 2007 with more than 30 years of dedicated service to the citizens of Wisconsin.

Mimi started her state employment career in the Department of Health and Social Services, Division of Vocational Rehabilitation on March 7, 1977. Mimi soon promoted to the Department of Natural Resources as an account examiner in the Bureau of Finance. Mimi advanced through the ranks by her willingness to do new things and take on more difficult assignments in her nine years in the Bureau of Finance. In 1987 she transferred to the Bureau of Program Services (Fleet) and was responsible for the department's truck and heavy equipment reporting system as a fleet specialist. In November 1999 she accepted a special assignment to the South Central Region to manage the maintenance and upkeep of its administrative facilities and to oversee the fleet operations of the region. This assignment became permanent in June 2000 when she became the facilities and fleet coordinator at South Central Region.

As the South Central Region fleet coordinator, Mimi's input was critical to the development of the new Automated Vehicle Operation Report (AVOR) system, the implementation of a new statewide vehicle maintenance contract with ARI, and the development of a new program to monitor driver eligibility while still expertly managing the South Central Region fleet.

Dedicated service truly describes Mimi's approach to her responsibilities while working in finance, fleet or facilities management. Her untiring work ethic and problem solving abilities truly benefited what ever job she tackled. We especially appreciate and applaud her effective and resourceful management of the South Central Region Fleet during the department's budget reductions.
