
**SUMMARY:**

**RECOMMENDATION:** Adopt Retirement Resolution for Michael L. Ries







## *Retirement Resolution*

Michael L. Ries, RLA, ASLA; has retired from the Department of Natural Resources (DNR) on July 21, 2008, after completing more than 34 years of dedicated service to the Department. Throughout his career, Mike was responsible for developing feasibility studies and master plans, and designing numerous recreational facilities for DNR properties. Mike also provided valuable consulting services for local, state, federal governments and other organizations in the areas of natural resource planning and recreational facility development.

Mike obtained his BS ('71) and MS ('73) in Landscape Architecture from the University of Wisconsin-Madison. His Master's thesis, published by University Extension, focused on design standards for recreation accessibility and was dedicated to his friend, Truman Karabis.

Mike's career with the Department began March 18, 1974, as a Novice Landscape Architect for the Bureau of Parks and was especially noted for his advocacy for accessibility for people of all abilities at public recreational facilities. In April of 1976, Mike was promoted to Intermediate Landscape Architect and, in the same year, to Senior Landscape Architect for the West Central District (WCD) based in Eau Claire. In addition to supporting the WCD, Mike provided Landscape Architectural services for the entire Northwest District. During his sixteen-year tenure in the Bureau of Parks, Mike wrote the master plans and provided design services for three new state parks, Natural Bridge State Park, Kinnickinnic State Park and Hoffman Hills State Recreation Area; and wrote the initial master plans for all of the other established state parks and trails in the WCD. In addition, Mike wrote the master plans and provided design services for many new trail systems including the popular LaCrosse River Trail and the Red Cedar Trail.

In 1989, Mike was reassigned to the Bureau of Resource Management (currently Bureau of Facilities and Lands) and began planning and design work for all types of DNR properties. Of particular note was Mike's leadership on the Western Prairie Habitat Restoration Area, a 20,000-acre bird and wildlife habitat project and the Lower Chippewa River State Natural Area, a 12,500-acre prairie, savannah and habitat protection area.

Mike has been recognized many times during his career, including many commendations from the different programs for which he has provided services and a lifetime achievement Award from the Wisconsin Chapter of the American Society of Landscape Architects.

Mike's contribution to the Department is evident in the following quotes from his colleagues:

"Mike was an enjoyment to work with and I learned a lot being around him. Mike should feel proud of his numerous contributions that he has made across the State Park system; for the enjoyment of thousands of park users each day AND that will continue to be used long after he has left his service to the State."
