

SUBJECT: LAND ACQUISITION – GLACIAL DRUMLIN STATE TRAIL – DANE COUNTY

FOR: JUNE 2009 BOARD MEETING

TO BE PRESENTED BY: Richard Steffes

SUMMARY: The Department has obtained an option to purchase 29.2 acres of land from Michael Pfefferle for \$175,200 for the Glacial Drumlin State Trail in Dane County. The item is being submitted because the purchase price exceeds \$150,000.

The parcel will provide an additional 700 feet of trail connection. This parcel will act as one of the links needed to connect the Glacial Drumlin State Trail with the Capital City State Trail, which runs through Madison and connects with the Military Ridge State Trail. This parcel is one of several needed for a continuous trail from Milwaukee to Dodgeville. Two additional parcels are needed in the area between Cottage Grove and Madison. A few parcels are needed at Jefferson.

The Glacial Drumlin State Trail opened to the public in 1987 and serves approximately 200,000 bikers, hikers, cross-country skiers, and snowmobiles each year. The trail follows an abandoned railroad grade from Waukesha and it currently ends in Cottage Grove because the railroad corridor to Madison is still active.

In 1998, the Department entered into a partnership agreement with the City of Madison, Dane County and the City of Fitchburg for the development of the Capital City Trail. Under this agreement, the Department is responsible for completing the Glacial Drumlin State Trail between Cottage Grove and Madison. This four-mile gap will be purchased, developed and operated by the Department of Natural Resources. The cities and county will develop the Capital City State Trail between the Glacial Drumlin and Military Ridge State Trails. The gap between Cottage Grove and Madison is the last remaining gap in this trail system.


The land is primarily wetland and will be managed for open space and wildlife habitat along with adjoining county land.

RECOMMENDATION: That the Board approve the purchase of 29.2 acres of land for \$175,200 for the Glacial Drumlin State Trail in Dane County.



JUSTIFICATION:

The Pfefferle parcel of 29.2 acres is recommended for purchase as part of the Glacial Drumlin State Trail. The parcel will provide an additional 700 feet of trail connection. The landowner would not sell a smaller parcel. This parcel will act as one of the links needed to connect the Glacial Drumlin State Trail with the Capital City State Trail, which runs through Madison and connects with the Military Ridge State Trail. This parcel is one of several needed for a continuous trail from Milwaukee to Dodgeville.

The Glacial Drumlin State Trail opened to the public in 1987 and serves approximately 200,000 bikers, hikers, cross-country skiers, and snowmobiles each year. The trail follows an abandoned railroad grade from Waukesha and it currently ends in Cottage Grove because the railroad corridor to Madison is still active.

four-mile gap will be purchased, developed and operated by the Department of Natural Resources. The cities and county will develop the Capital City State Trail between the Glacial Drumlin and Military Ridge State Trails.

The trail, when developed in this area, will switch back from north to south of and parallel with the active railroad corridor. The crossings will be at town road crossings. Two privately owned parcels remain in this area. Due to wetland soils, the trail may be developed using a floating boardwalk. The extra land on the Pfefferle parcel will provide area for wildlife habitat along with two adjoining Dane County owned parcels.

The Department recommends the acquisition of the Pfefferle parcel to connect the Glacial Drumlin State Trail to the Capital City Trail in Madison and also for public recreational use. The trail provides recreational opportunities in a heavily populated area of the state.


