This letter is to inform the DNR that I have changed consultants for the project at 864 Mather in Green Bay WI. I have selected REI Engineering, Andrew Delforge, P.G. and Ken Lassa as my contacts. I am no longer working with Mach IV Engineering.

Although this project has been continuing for many years I will attempt to summarize the events that have recently taken place. I sent out a RFP for the remedial action phase in 2012 and only received 2 proposals rather than the required 3-6 proposals per chapter NR 169, Wis. Admin. Code.

I would like to proceed with the viable proposal (prepared by Mach IV) but would like to hire REI to complete the work. Hi Keld – we have been discussing this site with Ken Juza the RP. I know you maybe aren't intimate with the details yet but I had a couple questions.

I have very little knowledge about this site but I took a quick look at the file to get a better idea of the current site status.

The approved remedial action was for a CAP 18 injection – are you comfortable with this strategy? I'm not familiar with the product, just curious if you've seen it used successfully

As far as I remember, I have not had a site using CAP18 ME. That said, it appears to be edible oil based which is fairly common to use for remediation of chlorinated solvents.

Does REI need to do a remedial action proposal for Ken? I have not reviewed the costs, but would assume we could do it for whatever Northern/Shaw's approved amount was. Looks like Mach IV copied Northern's proposal almost word for word

It looks like the site monitoring wells have not been sampled for quite some time. Do you think it would make sense to have the monitoring well network sampled prior to deciding how to move forward?

Ken Juza didn't have any documentation of the SVE system. Based on our conversation with him, it was nothing but trouble. It was hard to tell from BRRTS if there was a construction documentation report/as built, or any O&M reports I just scanned and uploaded the Remedial Design Report to BRRTS on the Web for your use.

It looks like there haven't been any DERF costs submitted or claimed since 2010. Northern just sampled the groundwater from 2010 to 2016 when Ken Juza hired Mach IV and Mach IV never billed him anything, so hopefully there aren't a ton of costs outstanding. REI will need to work with the RP and Northern/Shaw to get copies of invoices and cancelled checks. Sounds good.
