I have links to reports below; there were no sub-slab VRSL exceedances for vapors beneath Edward Jones on 3/18/20, but there were vapor action level (VAL) exceedances in indoor air on 3/18/20 and 5/20/20. Edward Jones did not have immediate action level exceedances (equal to 3x the VAL) during the two sampling events, which would warrant immediate response with filtration. The sampling on 5/20/20 was "post-mitigation", however from my understanding, the vapor mitigation system installed beneath Edward Jones, Former Williams Tae Kwon Do, and One Hour Martinizing was NOT running as the blower fan ceased operation prior to the sampling event and was not replaced until a later date.

For reference, the vapor risk screening level (VRSL) for tetrachloroethylene (PCE) in sub-slab vapor samples in a commercial setting is <u>6,000</u> micrograms per cubic meter (ug/m3) and the vapor action level is <u>180</u> ug/m3. Please refer to the <u>Wisconsin Vapor Quick Look-Up table</u> for the most common contaminant vapor screening concentrations. Unfortunately, we do not have a consolidated table of all testing results, but we will hopefully receive one once this most recent round of sampling is completed and submitted as a report.
