GHD Services Inc. (GHD) has prepared this monthly status update for the period of October 2019 for the Penta Wood Products Superfund Site (Site). The project budget and costs are summarized in the following Table 1. All problems, resolutions, and/or recommended solutions with an assessment of data collected during this period will be provided in the next Semiannual Report – July through December 2019. The following is a brief summary of the work completed.

Phase 06-Task 01 Site safety plan preparation

No costs were billed to this task in the current invoice.

Phase 06-Task 02 Housekeeping and grounds keeping

- Heat trace cable was installed on the riser pipe in the building for the water supply well.
- This invoice includes subcontractor (El Stinko Portable Toilets) costs for rental of a portable sanitary facility used during the October 2019 semiannual groundwater monitoring and sampling equipment event.
- This invoice includes subcontractor (Beisswenger's) costs for purchase of heat trace cable and supplies.

- Residential well sampling result letters were prepared and subsequently issued on November 15, 2019.
- This invoice includes laboratory subcontractor (Eurofins TestAmerica) for residential well sample analyses.
