


# 2016 Farmland (Zone 2) Antlerless Deer Tag Information

# Selecting Farmland (Zone 2) Antlerless Deer Tags in 2016



## Farmland (Zone 2) Antlerless Deer Tags:

- may be filled during any deer season with the allowed weapon.
- are Deer Management Unit (DMU) and land type (public or private) specific. The hunter must specify the DMU and land type. If more than one tag per license is offered in the DMU, different land types may be chosen for each tag.
- may be used by Class A & C disabled permit holders and certain active duty military personnel on leave to harvest an antlerless deer in any DMU statewide while hunting on the land type specified on the tag, including buck only DMUs. See the *2016 Deer Hunting Regulations* for details.
- may be selected by Junior deer hunting license holders in addition to the Junior Antlerless Deer Tag included with their deer hunting license. However, they are valid only in the DMU and land type specified on the tag.

## Deer Management Zones and Deer Management Units

The state contains two farmland Deer Management Zones where up to three Farmland (Zone 2) Antlerless Deer Tags may be included at no cost with the purchase of each deer hunting license. Both zones contains several DMUs, most of which can be identified by county boundaries and names. Note that nine DMUs (Adams, Clark, Eau Claire, Jackson, Juneau, Marinette, Monroe, Oconto and Wood) are each split by zone boundaries. ***Farmland (Zone 2) Antlerless Deer Tags may be used only in the DMU and land type specified on the tag.***



***\*If you have already purchased your deer hunting license or wish to defer your DMU selection to a later date, your options are:***

1. Accessing your Go WILD account at home, then select your tag(s) and print at no cost
2. Request your tag(s) at a local DNR Service Center at no cost
3. Request your tag(s) at a license agent which will require a \$2 processing fee
