2008 Hunting Incident Report Executive Report

Hunting Incident -- is when a person is injured by the discharge of a hunting firearm or bow and arrow arising from the activity of hunting, including travel to and from the hunting field.

There were 30 total hunting incidents during the 2008 hunting season. Two were fatal. Thanks to the efforts of our hunter education program hunting is a safe activity in Wisconsin. Hunting incidents are continuing a downward trend and for 2008 we were below the 10 year average of about 45 incidents per year.

Gun deer hunting, pheasant hunting and waterfowl hunting were the three hunting activities with the highest number of incidents with gun deer hunting having the most. Turkey hunting involved only 1 incident showing a decrease. Grouse and squirrel hunting remained basically the same compared to 2007.

Rifles and shotguns remain the hunting implement involved most often in hunting incidents. Shotguns continue the trend of being involved more often (60%) than rifles.

Major causes for incidents for 2008 include: Trigger caught on object and victim out of sight of shooter.

Self inflicted injuries accounted for 54% of the total number of incidents. This is a significant change as over time about 33% of all incidents have been self inflicted injuries.


Juveniles (under age 18) caused 13% of the total number of hunting incidents. That means that 87% of all hunting incidents were caused by adult hunters. This continues a significant drop in the incident rate for juveniles causing hunting incidents. Historically juveniles have contributed to nearly 33% of the total numbers of incidents.

To summarize this report, hunters, education instructors, sportsman organizations, and Conservation Wardens should be congratulated for making 2008 a safe year to hunt in Wisconsin. We were well below the 10 year average for hunting incidents and expect to continue that trend into the future. Self-inflicted injuries and incidents during deer drives were significant issues in 2008. While this is one of the safest seasons ever we cannot rest on past success and must stress the importance of knowing and practicing the 4 basic rules of firearms safety every time we handle a firearm. Remember the slogan "Safe Hunting is No Accident." Let's make 2009 the safest season ever.




History of Hunting Incidents



History of Fatalities




Wisconsin Hunting Incident Rate Per 100,000 Hunters






Incidents by Day of Week











Members of the Same Hunting Party (includes self-inflicted injuries)












Distance From Muzzle to Wound











Incidents by Day of Week


