NHAL Timber Sale Bid Mailing List:

Enclosed please find a Northern Highlands American Legion State Forest prospectus sheet and timber sale management maps for the upcoming bid opening. **Minimum total bid prices are listed for each sale. Advertised per unit prices do not need to be met. An acceptable bid must be equal to the total minimum bid price or higher. All species and products must be bid on or bids will be rejected.**

Included in this prospectus are descriptions of the individual timber sales, volumes and minimum total bid prices. Please note that bids for each individual sale can be mailed to Trout Lake or dropped off at the Trout Lake Forestry Headquarters. If you are dropping them off on the day of the bid opening, **May 1<sup>st</sup>**, please have them at Trout Lake by 1:00 p.m. The bids will be opened at 1:30 p.m. at the Boulder Junction Community Center. You are invited to attend the opening.

Successful purchasers of Northern Highland-American Legion State Forest stumpage will need to ensure that the actual logging contractor complies with the Wisconsin Sustainable Forestry Initiative (SFI) Training Standard as adopted by the Wisconsin SFI Implementation Committee (SIC). This will be required prior to starting sale (contract signing).

To qualify for state sales all loggers must meet certain criteria to be considered a "Qualified Logging or Resource Professional. The requirements are as follows:

**Qualified Logging or Resource Professional:**

**Professional Training** – (once every two years) Choose one of the following: Chainsaw Safety, Mechanized Training, Log Truck Driver Training, Business Management, Cross Training for Loggers & Foresters, Invasive Species, or Threatened & Endangered Species.

**1<sup>st</sup> Aid/CPR:** One time only\*

**Best Management Practices (BMP)** – One time only\*\*

**Continuing Education** – (8 hours annually) Includes loggers' conferences and continuing education workshops offered in the 2006 SFI<sup>®</sup> Workshop Brochure

*At a minimum, the Contract Holder and one "in-woods" person actively responsible for each logging site must be a "Qualified Professional". In some cases, the Contract Holder may also be the "in-woods" person.*
