Township 39 North, Range 9 East, Sugar Camp Township, Oneida County, WI


A parcel of land being a part of the SW $\frac{1}{4}$ -NW $\frac{1}{4}$, Section 1, and a part of the NE $\frac{1}{4}$ -NE $\frac{1}{4}$ and the SE $\frac{1}{4}$ -NE $\frac{1}{4}$, Section 2, all in Township 39 North, Range 9 East, Sugar Camp Township, Oneida County, Wisconsin, and being more particularly described as follows: Commencing at the Northwest corner of said Section 1 being marked by a Vilas County aluminum capped monument; thence S04°14'00"W 315.60 feet (S04°52'38"W of record) along the West line of said Section 1 to an iron pipe and the PLACE OF BEGINNING; thence continuing S04°14'00"W 450.03 feet (S04°52'38"W of record) along the West line of said Section 1 to an iron pipe marking the Northwest corner of the SW $\frac{1}{4}$ -NW $\frac{1}{4}$ of said Section 1; thence N89°26'26"E 675.05 feet (N89°54'52"E of record) along the North line of said SW $\frac{1}{4}$ -NW $\frac{1}{4}$ to an iron pipe; thence S00°31'27"E 49.86 feet to an iron pipe; thence S89°26'00"W 729.11 feet to an iron pipe; thence N04°11'58"E 504.30 feet to an iron pipe; thence S85°43'57"E 50.05 feet back to the Place of Beginning.

The Department will provide title to the above-described property to the Glembin's as part of a land exchange that will resolve occupancy issues caused by survey errors.
