**Supplemental DNR Brownfields SAG Funds Awarded For 2003-2005 Biennium**

The DNR's RR Program awarded supplemental funding to communities that received Brownfields Site Assessment Grants in 2004 and 2005.

The supplemental funds were available because some communities declined their Round 6 grant awards (given out in 2005), and some recipients were not able to spend all their Round 5 grant monies, resulting in available funding after final reimbursement claims were processed.

Therefore, RR Program staff were able to award 20 supplemental grant awards to communities that received grants in Round 5 and 6. Grant recipients who submitted written requests were eligible for increases of up to 10 percent of the original grant amounts. The funds will be used for additional eligible grant activities on the project sites, and all awards made were processed as amendments to the existing grant agreements already in place.

Communities who receive Site Assessment Grants are able to request an increase in their grant award in accordance with NR 168.21, Wis. Adm. Code, if their project needs additional funding and the DNR can approve these requests if money is available. A total of 23 requests for \$78,553 were received. Twenty awards for a total of \$54,792.56 were granted. These are the last awards that will be available for Round 5 and 6 grant recipients, since all available funds must be encumbered prior to the end of the state's 2003-2005 biennium, which is June 30, 2005.
