



Retirement Resolution

Linda L. Evans, Natural Resources Office Operations Associate, retired from the Wisconsin Department of Natural Resources on July 31, 2009 after more than 41 years of service.

Linda began her career with the Department of Natural Resources in October 1973, at the F.G. Wilson State Nursery as a Typist II. Through the years, her position evolved to a Natural Resources Office Operations Associate. Linda's duties were challenging, rewarding and diverse. She served the public through license sales, recreational vehicle registration and answering endless questions, as well as supporting DNR staff in Forestry, Wildlife, Facilities and Lands, and Law Enforcement. Linda is a true team player, always willing to help where needed to get the job done. "It's not my job" is not in her vocabulary. Because of that attitude, others in the office were willing to help her out as well; like the year Linda sold the most "Bonus Deer Tags" in the state. Many customers come back year after year, just to see Linda. Spring is another challenging time of year, when the nursery may hire as many as 100 LTEs in a single day.
