**SUBJECT:** The Ox-Bow Sportman's Club will donate \$10,000 to be used towards the Aders Creek Restoration Project on Brillion Wildlife Area.

**SUMMARY:**


The Ox-Bow Sportsman's Club will be donating a total of \$10,000 to be used towards several projects within Calumet County on Department lands. First is the Aders Creek Restoration Project which is the largest area for the donation (\$7500-\$8500). Of this amount they have spent \$450 for a permit from Calumet County for the Department to be able to do the work. One of the other areas for the donation (\$1000) go towards aerial spraying on the Brillion Wildlife Area near the North Branch of the Manitowoc River. This is for re-establishing the river channel which has been choked by cattails. The last part of the donation (\$500-\$1000) is to go towards wetland restoration/maintenance or grassland maintenance projects within the Brillion or Killsnake Wildlife Areas.

**RECOMMENDATION:** Accept the generous donation of \$9,550 & permit payment for \$450 from the Ox-Bow Sportsman's Club for a grand total \$10,000.
