2. The eligible costs under ch. NR 154 exceed those under ch. NR 120.

\*\*Bonding funds may be used for spill control facilities only! **Separate** bond-eligible components **from** non-bond-eligible components on pay request.

\*\*\*R20 includes permanent BMP components, such as permanent boundary and paddock fences, watering systems, and erosion stabilization.

\*\*\*R20T includes temporary BMP components, such as portable watering systems.

**NR 154.03(j) Cropping Practice Flat Rates:**

\$9.00 per acre for contour cropping

\$13.50 per acre for strip-cropping

\$&.50 per acre for field strip-cropping

\$18.50 per acre per year for high residue management systems

\$25 per acre per year for cropland protection cover (green manure)

\$6 per acre for first year of nutrient management plans and \$4 per acre for subsequent years of nutrient management plans

**\*NR 154.03(j)6 Fencing Flat Rates**

\$5.00 per linear rod/3 strand barbed wire/steel or wooden post

\$8.00 per linear rod/woven wire/steel or wooden post

\$3.00 per linear rod/2 strand elec/fiberglass, steel, wooden post

\$7.40 per linear rod/high tensile wire/fiberglass posts
