## 5. Public Participation

- WATVA (Randy Harden)
  - O UTV weight and width continues to be an issue, dealers are selling vehicles that can't be registered in Wisconsin. Legislation may be introduced to increase the allowable weight, but width is unlikely to change.
  - Speed has also been an issue on the trails. On routes, speed limit is as posted for vehicles unless posted otherwise.

  - Grant requests exceed the amount of available grant funds under the spending cap this year. The funds exist in the account but we cannot access them due to the Chapter 20 spending cap.

## LAW ENFORCMENT REPORT

• With the close of 2019 brings the first full year of the Dept. of Natural Resource's re-organized Recreation Warden Team. The Recreation Warden Team is comprised of 10 wardens (2 stationed in each region) who specialize in recreational vehicle crash investigation, specialized recreational vehicle enforcement, and off-highway vehicle training operations for conservation wardens. We expect the Recreation warden team to continue to provide great service to the citizens of Wisconsin.

- Wardens have realized an ever increasing number of ATVs & UTVs using Wisconsin's trails and roadway routes this year. The sport continues to expand.
- To date this year, 2020, Warden's and their partner law enforcement agencies to date investigated 14 fatal ATV incidents, 13 fatal UTV incidents, for a total of 27 fatal incidents so far this year.
  - Of the 13 fatal UTV incidents, none were wearing their seatbelts.
  - Of all the incidents only two were wearing helmets, both ATV related.
  - $\circ$   $\;$  This compares to 22 total fatal ATV/UTV incidents in all of 2019.
- In an attempt to expand safety messaging, the Department purchased a digital message board, similar to those orange message boards used in construction zones. This will allow wardens to post safety messages in real time at trail heads and other high use areas in an attempt to reduce crashes and to provide for over-all safe ATV/UTV operation.

8. Information and Action: Council Recommendations to DNR on Implementing Grant Funding Changes from <u>2019 Wisconsin Act 183</u>, Legislation ATV/UTV SB-583 AB-652

New funding categories of Radio Equipment, Safety Signage and Statewide Digital Information Applications should be available for funding requests as of April 15, 2021.

Discussion on Communication Equipment – focus would be on two-way communication systems. Intent in drafting legislation was for use in trail ambassador program, but not exclusive use. Tower construction and cellular phones would not be eligible under the program.

Discussion on Safety Signage – purpose would be purchase and placement of safety signage on trails or trailheads – proper use of safety equipment, reminder about safety regulations, etc. Design and color needs to be consistent with the Signage Handbook.

Discussion on Statewide Digital App – professional labor and contracted services to develop a digital application (such as mobile app, or website). Grant funds would be for services free to user. Any paid/add-on features would have to be developed without grant funds.

#### 9. Council member items

**Dave Traczyk** – Let's talk more about dust control, and the spending cap that limits the amount of the program balance that can be spent on grant projects.

Dan Thole – no comments

**Jim Wisneski** – Any interest in doing a SNARS equivalent for ATV? And thanks for approving the Wolf River Bridge.

**Rob McConnell** – Seal coating is becoming more popular, FYI

Adam Harden – Dust, speed and lack of education (helmets, etc) are an issue in the sport. Spike in users but education of those users not keeping up.

**Bobby Donahue** – Concerned about education of users, should begin with the dealer.

**Mike Biese** – Echo comments on safety and education needed with new users. Misinformation being spread on social media. More miles of trail would be ideal, though routes are also sometimes necessary.

#### Public Comments

**Ed Slaminski (DNR)** – Retiring soon, has been working with the grant programs for 13 years, and will continue to be a motorized user.

**Don Mrotek (Snowmo Council)** – FYI, GPS units will be required in the future, 700 units needed yet in the groomers. Thank you for your cooperation on funding joint projects.

#### 10. Next meetings

- Ad hoc committee of the Council may meet Nov 5<sup>th</sup> to discuss the new funding categories. Meeting will be organized by members of the Council.
- Next official Council meeting will likely be in the winter of 20-21, date TBD.
- Topics for future meetings include dust control, priority ranking of new funding categories vs. existing categories, and increasing the Chapter 20 spending cap for grants.
- Need to formally approve Equipment Rates for 20-21.
