## **Next Steps for Storm Water Applicants of the Clean Water Fund Program**

Deadline
For State Fiscal Year (SFY) 2025 funding, you must submit your CWFP Financial Assistance Application with all required
<u>documentation</u> through the <u>online system</u> :
<ul> <li>If competing for <u>principal forgiveness (PF)</u>, applicants must submit the complete CWFP application by September 30, 2024.</li> <li>If not competing for PF during SFY 2025, it is recommended that applicants submit an application by the September 30, 2024 deadline due to potential limitations on loan capacity. Visit our webpage on <u>Loan Capacity</u> for more information.</li> </ul>
Plan reviews by DNR Bureau of Watershed Management
Storm Water Facilities Plans
An approved facilities plan is a requirement of the application. Any project seeking CWFP funds must be submitted to DNR for plan review and approval. The facility plan should include a cost-effectiveness analysis and address the need or purpose of the project.  Submit required copies of the facilities plan to the DNR regional storm water engineer or to the DNR central office storm water engineer (Amy Minser) for approval, prior to submittal of construction plans and specifications. Provide enough lead time (preferably six months) before the September 30 application deadline for the DNR to complete the facilities plan review.
□ Include a <u>parallel cost estimate</u> .
Plans and Specifications Submittal: Follow requirements as explained in DNR's Storm Water Technical Standards, Models, and Bes
Management Practices.
□ Plans and specifications must be submitted in an approvable state, prior to or concurrent with the application submittal. Applicants should email plans & specs to the DNR regional storm water engineer or to the DNR central office storm water engineer <i>and</i> upload electronic copies of the plans & specs with the application.
Accomplish in the near future:
□ Pass a Reimbursement Resolution.
□ Prepare an <u>equipment replacement fund</u> schedule.
Federal requirements
Applicants must comply with:
□ Cost and Effectiveness Certification — required for all projects at the time of application submittal.
□ Davis-Bacon and Related Acts (DBRA)
□ <u>Disadvantaged Business Enterprises (DBEs)</u>
□ Environmental Review
☐ American Iron and Steel
☐ Build America, Buy America (BABA) — required only for projects designated as federal equivalency.
☐ <u>Bipartisan Infrastructure Law Signage</u> — required for projects receiving PF and those designated as federal equivalency.
