
#### **REGULATION CHANGES FOR THE 2024-2025 FISHING SEASON**

The regulation changes in this document go into effect April 1, 2024 except as otherwise noted. The new regulations are divided alphabetically by county within existing Fisheries Management Districts. Check the *Guide to Wisconsin Trout Fishing Regulations, 2024-2025* and the *Guide to Wisconsin Hook and Line Fishing Regulations, 2024-2025* for fishing regulations on other waters and general statewide regulations.
