

Red Pine Thinning (43 acres): Cut all merchantable aspen, fir, jack pine, and orange marked trees.



Aspen Mix (25 acres): Cut all orange marked trees only.



Aspen Removal Area (13 acres): Cut all merchantable aspen trees



Hemlock Thinning (8 acres): Cut all merchantable aspen, fir, maple, white birch, and orange marked trees.

Note: Do NOT cut any green marked trees or any trees within 15 feet of the flowage. Equipment must stay at least 15 feet away from the flowage and do NOT fall any trees into the flowage. Do NOT damage residual trees.

No bid bond is required.

15% of the total sale bid value or \$1000.00, whichever is greater, will be required for performance bond.

The cutting area is approximately 89 acres.

The contract period is 3 years.

All trees that will yield one or more 100-inch sticks to a 4" top diameter will be cut and utilized. Whole tree utilization/biomass harvesting is not allowed.

Note: Total sale volume equates to 23 tons/acre or 11 cords/acre.

#### **Special Conditions:**

- 1. All pine products cut between April 1 and September 1 must be removed from the sale area within three weeks from time of cutting. Pine products cut during the remainder of the year must be removed prior to April 1 of each year.
- 2. Cutting must be concurrent for all species.
- 3. Do not cut, knock down or utilize any dead trees, except they may be cut down along roadways where they pose a safety hazard.
- 4. Slash within 50 feet of all roads, trails, and waterbodies must be lopped and/or scattered to lie within two feet of the ground and be pulled back 10' behind the tree line concurrently with cutting.
- 5. Follow WI BMP's for water quality at all times. No equipment is allowed within 15 feet of waterbodies and no trees are to be cut within 15' of the flowage, river, or beaver pond. Avoid wetlands as much as possible and only operate within them during very dry times with timber matting or under frozen ground conditions. A few small wetland area crossings will be needed within the sale area.
- 6. Landings and new logging roads generally must be 200' or greater from the flowage. Roads and landings must be approved by the Willow Flowage Property Manager in advance of use.
- 7. For the area identified as "Zone A" on the timber sale map, No harvest activities between January 15 July 30. Zone A includes a portion of the Aspen Removal and Aspen Mix areas of the timber sale that is located south of Flowage Road in the eastern portion of the timber sale.
- 8. Access to the southwestern cutting units may require timber mats, access from adjoining landowners (to be negotiated by the contractor) and/ or frozen ground.
- 9. Appropriate signage along roads shall be posted to alert recreational users and local residents of logging activity.
