Water Quality Trading Plan – CONDITIONAL APPROVAL

Dear Mr. Hendrickson:

The Department recently received a water quality trading plan (WQT Plan) for compliance with phosphorus & TSS effluent limits at Seneca Foods - Mayville. The initial plan was received in October of 2020 and an updated version was received in January 2021. Based on WDNR review, the final WQT Plan (dated January 2021) is in general conformance with the WDNR Water Quality Trading Guidance and Section 283.84 of the Wisconsin Statutes. Credits generated from approved practices result in available credit quantities shown in Table 1. These credits will be incorporated into the reissued WPDES permit and will be used to demonstrate compliance with final phosphorus & TSS effluent limits beginning October 1st, 2023.

This approval is not to be construed as an approval for any activities requiring a permit under ch. 30 or 31, Wis. Stats. The Department has assigned the WQT plan a tracking number of WQT-2021-0003 and will be referenced as such in the draft WPDES permit. The final WQT plan will be included as part of the public notice package for permit reissuance. The draft WPDES permit will include a requirement for an annual trading report and effluent monitoring for total phosphorus.
