## 2013 MFL Recertification

The Forest Tax Program has established the 2013 Training Schedule for the annual MFL Recertification sessions. This training is mandatory for all Certified Plan Writers (CPWs) and Department of Natural Resources Foresters who write and review MFL plans and enforce the MFL program.

The 2013 MFL Recertification Sessions are two days. Day 1 is a joint meeting between DNR Foresters and CPWs. Day 2 is a meeting for DNR Foresters.

Please register by December 31 for the session(s) you wish to attend.
