2014 MFL Recertification



The Forest Tax Program has established the 2014 Training Schedule for the annual Managed Forest Law (MFL) recertification sessions. This training is mandatory for all Certified Plan Writers (CPWs) and Department of Natural Resources Foresters who write and review MFL plans and enforce the MFL and Forest Crop Law (FCL) programs.

The 2014 MFL Recertification Sessions are one day this year. This day will be a joint meeting between DNR Foresters and CPWs.

Please register by July 15 for the session you wish to attend.
