

Wood Furniture Manufacturing Operations MACT

INITIAL NOTIFICATION REPORT (Wisconsin Department of Natural Resources-7/96)

You are required to submit an initial notification if you are the owner or operator of a facility that is engaged, either in part or in whole, in the manufacture of wood furniture or wood furniture components; and which emits or has the potential to emit 10 tons per year of any single hazardous air pollutant (HAP), or 25 tons per year of any combination of HAPs; and do not meet one of the exemptions provided in the standard. If you have a permit from the DNR which restricts your HAP emissions to less than these levels, you do **not** have to submit an initial notification. Existing source (on or before December 6, 1994)	September 3, 1996
Between December 7, 1994 and December 7, 1995	April 5, 1996*
After December 7, 1995	120 days after initial startup

*If you have missed this deadline, submit an initial notification as soon as possible, but no later than September 3, 1996.

1. This notification is being made for:

Doing so before your final compliance date will exempt you from the requirements of the Wood Furniture Manufacturing Operations MACT standard.
