

Wisconsin DNR Hunting Heritage Photo Contest – November 2012

1. Go to the Wisconsin Department of Natural Resources page on "Facebook", click the "Like" button, and submit a photo between November 17 and November 28, 2012 for your chance to win a three year subscription to Wisconsin Natural Resources Magazine. Those who are current "Fans" of the Wisconsin DNR's facebook page can also enter by clicking the "Hunting Heritage Photo Contest" box on the top of the page.
2. Entrants must be at least 13 years old. Employees of Wisconsin Department of Natural Resources and their immediate families may enter the contest but may not be awarded the prize.
3. The contest entry period is Saturday, November 17, 2012 – Wednesday, November 28, 2012. Each "Fan" of Wisconsin Department of Natural Resources can only submit one photo in the contest per day. However, if a "Friend" of an entrant submits a photo in the contest, the initial entrant automatically receives an additional 5 (five) bonus votes.
4. Odds of winning are determined by the number of entries and votes submitted by the public.
5. One winner will be chosen by public vote. Whoever has the most votes by 11:59 p.m. on Wednesday, November 28, 2012 will be deemed the winner. The winner will be announced on the Wisconsin Department of Natural Resources website (<http://dnr.wi.gov>) on Friday, November 30 and then posted on Facebook.
