	<p><u>Mixed Dry Forest</u></p> <ul style="list-style-type: none"> • Harvest of the merchantable jack pine may occur • Black locust trees will be controlled using basal bark applications of herbicides. • Savanna management will consist of removal of invasive exotics, thinning non-native and native understory trees, and plying prescribed fire. <p><u>Dry Prairie</u></p> <ul style="list-style-type: none"> • Removal of woody species and prescribed fire <p><u>Floodplain Forest</u></p> <ul style="list-style-type: none"> • Removal of exotic species when found <p><u>Exposed and Shaded Cliffs</u></p> <ul style="list-style-type: none"> • Establishment and enforcement of closed zones prohibiting visitor access to sensitive cliff and canyon areas • Monitoring by conducting periodic population censuses of each species <p><u>Conifer Plantations</u></p> <ul style="list-style-type: none"> • Thinning large pines <p><u>Alder Thicket/Shrub Swamp</u></p> <ul style="list-style-type: none"> • Removal of invasive exotic species if found <p><u>Open Wetland</u></p> <ul style="list-style-type: none"> • Removal of invasive exotic species if found <p><u>Agricultural Land/Pasture</u></p> <ul style="list-style-type: none"> • Removal of invasive exotic species <p><u>Old Field</u></p> <ul style="list-style-type: none"> • Removal of invasive exotic species if found
