Thank you for submitting Technical Memorandum – Work Plan Addendum No. 2 for department review. The department previously reviewed and concurred with TRC’s Site Investigation Work Plan and Technical Memorandum – Work Plan Addendum No. 1. This review focused on Wauleco’s concurrence request for the following:

- Proposed general sampling locations for background sources
- Proposed approach and locations for the data gap samples
- Concurrence that the information the WDNR is seeking concerning other potential background sources will be provided to Wauleco for review and potential adjustment of this proposed sampling approach, prior to the proposed soil sampling being performed.

The department concurs with the general sampling locations proposed for background sources. The department also concurs with the approach and proposed locations for the data gap samples; however, the department requests that an additional soil sample be collected in the vicinity of 117/120 River Street. The purpose of this sample to assess current soil conditions in the vicinity of former soil sample locations.

Upon receipt of additional background information, the department will make available to Wauleco any information provided by potential background sources. The department encourages Wauleco to begin securing the necessary access agreements for sample collection upon receipt of this email.
