Good Afternoon Frank,

As we discussed over the phone earlier today, following review of the Upland RI Data Summary, the DNR had some areas that need additional evaluation and potentially additional sampling to address NR 700 series specific ARARs.

DNR recommends identifying areas that will require capping and evaluating the effectiveness of the current surface cover(s). Based on the data review, the existing cap may need to be expanded to include areas to the North, West and East.

 Areas of particular concern are the grass area between the parking lot and the Annex Building, and along the river and public trail, as outlined in the attached figure. As part of the evaluation, additional sampling of the current surface cover may be necessary to document that it meets the requirements for a direct contact cap.

Due to naphthalene present in the shallow soil approximately four times above the NAPL indicator level (reference RR-800) near the Annex, an additional soil gas sample should be collected between SG-401 and SG-402 near the SB-419 boring location, as shown in the attached figure.

I will send you a memo next week with the remainder of the comments pertaining to the NR700 rule series, and hope this information is helpful as you prepare for field work next week at the site.


