## Mike,

Thank you for your invitation to meet to continue discussion regarding redevelopment of the former Amcast property. As discussed during our June 1, 2023 meeting, DNR approval for site development is contingent on the submittal and approval of a development/materials management plan from the property owner. To date, a development/materials management plan has not been submitted to the DNR. For this reason, the DNR believes a meeting is premature. Once a development/materials management plan is submitted with a review fee and following adequate time for DNR review and preparation, we would be happy to participate in a meeting.

As previously discussed, the development/materials management plan should include, but is not limited to, figures and text describing the project, description of a soil sampling plan for the proposed development area, plan for disposal of soil generated from the project, and an evaluation of measures needed to be protective for future use based on the requirements of Wis. Admin. Code chs. NR 700 and NR 500 code series and the appropriate review fee. Review and approval by DNR and EPA are required to evaluate the project and to ensure the final design is protective.

The DNR looks forward to working with you on this project once a development/materials management plan is submitted. If the City has any questions in the meantime, please contact me. Regards,

Following up on discussion from a few months ago, as you know, I represent the City of Cedarburg. The City appreciates the WDNR's cooperation in addressing the Amcast Superfund site. I believe we made progress at the last meeting.
