## Dear Mr. Schreiner:

The Wisconsin Department of Natural Resources (the "department") received information regarding burning of waste material at the former window manufacturing operation located on the Wauleco site which may have resulted in uninvestigated soil contamination. It is the department's understanding that wood waste was disposed of (burned) at a rate of up to 400 tons per month at the site and that employees of the company operating at the site could take wood scraps home and burn them.

## Waste Records

The department requests information pursuant to Ch. 292.31(1)(d) Wis. Stats. regarding:

- 1. The type and quantity of waste generated, transported, treated or stored which was disposed of at the site or facility and the dates of these activities.
- 2. The identity of persons who generated, transported, treated or stored waste which was disposed of at the site or facility.
- 3. The identity of subsidiary or parent corporations, as defined in sub. (8) (a) 3., of persons who generated, transported, treated or stored waste which was disposed of at the site or facility.

Please provide the information related to the department's Ch. 292.31(1)(d) request within **60 days of this notification**, by March 16, 2019.

## Scope of Work

To date, the Wauleco site investigation and health assessment activities have focused on soil and groundwater contamination resultant of Penta solution spills; the department is requesting a scope of work be prepared to address aerial deposition of contaminants associated with the combustion of wastes generated at the facility. The work plan must comply with the requirements in Wis. Admin. Code, chs. NR 700 through NR 754. The law requires that you appropriately scope out your site investigation and submit a work plan within **60 days of this notification**, by March 16, 2019.
