Thanks for letting me know about those site files today.

As an FYI, I wanted to let you and the department know that I took a deep dive into some City/County utility files, and there appears to be some points in the neighborhood where sewer lines may have sat below contaminated groundwater, potentially for decades (and, if not, some points come very close -- which still strikes me as significant, given the possibility of water table elevations at times).

I thought this may be useful information as the investigation into possible utility corridor migration and vapor intrusion progresses.

Now that this land has been formally rezoned by the City of Wausau from industrial to residential, and the planning process seems to suggest future residential use, will non-industrial RCLs be the ruling standards for this property?

Also, on the incubator front, it is my understanding that operations like the Shuttery of Nanik were located around there. From what I have seen, it had a significant VOC and VOC emissions history prior to transitioning from solvent-based coatings to waterborne coatings.

You had asked about the City doing a Phase I. Below is an email from Mr. Lindman to Mr. Smith. Mr. Smith shared it with me, as I had expressed concerns about further disturbances to the site before the environmental investigations were done that the City told the public it would get. I would guess the Phase-I-states-no-concerns and no-recommendations-for-further-testing comments below from Mr. Lindman relate only to the structure and not the property in general -- as the public was informed by the City at a recent ED meeting that it was going to look at doing a refreshed up-to-date Phase I along with a Phase II (or, at least, Phase-II-style-testing).
