On April 19, 2019, OBG (Part of Ramboll), on behalf of Miller Compressing, submitted to the Wisconsin Department of Natural Resources (DNR) two reports for review: *Revised Cap Operations, Maintenance, and Monitoring Plan, April 17, 2019* (COMMP) and *Post-Closure Long-Term Care Plan, April 2, 2019* (LTCP) as part of the Remedial Design (RD) for the Burnham Canal site (Site).

	for a bathymetric survey and isopach maps and grain size analysis to compare
	with 5-year monitoring.
3.3.2	Please define and explain "Betterment Project fill" and provide a reference. Use
	consistent wording throughout the document.
3.3.2	Second paragraph looks out of place, should it be in the Purpose section?
4	Please cite the MOU and attach as an appendix.
4 (Whole Section)	Section 4 includes information relevant to other sections but was presented here
	first. Additionally, Section 4 repeats information already discussed in other
	sections. It is recommended that Section 4 is revised so that discussion is limited
	to the cost estimate specifically. Details of O&M should be moved to relevant
	sections.
4	Table 1 should include costs for storm related events and adjustments for
	inflation.
4	It is recommended that a cost summary sub-section is added with a table that
	shows the relevant costs for comparison purposes. Please provide a summary of
	the responsible parties and stakeholders and describe costs they are responsible
Primar.	for and any contingencies.
4.3	See comment for Section 3.3.1. The survey should capture enough information to
	compare with results from the initial bathymetric survey and inspections.
4.4	Please provide additional details justifying the maintenance budget. Please
	include references and/or CSO 194 project cost estimates and include them as an
	appendix.

Attached are two draft documents on financial assurance to give you additional information to help you better define and present your proposal.
