On behalf of Tyco Fire Products LP (Tyco), Arcadis submits the attached updated "Draft Project Schedule, Tyco FTC and Stanton Street, Marinette" for planned site investigation activities and submittals, in Gantt chart format. This schedule presents approximate dates for several work items and is an updated version of the schedule sent to the Wisconsin Department of Natural Resources (WDNR) March 12, 2020. Tyco anticipates updating this schedule on a quarterly basis to reflect current activities and conditions.

On May 27, 2020, WDNR sent Tyco three letters related to ongoing work in the Marinette area. While the follow-up discussions associated with those letters may influence some of the items presented in the attached schedule, Tyco is providing this updated schedule now in order to comply with a previous commitment to provide a schedule to WDNR on June 1, 2020.

Tyco's approach to preparing this schedule is to provide the WDNR with a list of pending activities, document submittals, and meetings/communication opportunities. As noted during the January 23, 2020 summit meeting between WDNR and Tyco, and as discussed since that meeting, this schedule is a "living document" and communication tool for conveying the planned sequence and timing of upcoming activities. Changes to the schedule are communicated as needed between the more formal schedule updates.

The rationale for sequencing and timing of tasks is provided in the notes at the end of the schedule. The notes also provide a description of the contents for some of the documents identified in the schedule. The sequence of tasks will allow WDNR to review data interpretations, followed by plans to address data gaps and then data collection to fill the data gaps. For example, Interim Site Investigation Reports (SIRs) will provide the compilation and interpretation of

existing data, followed by Site Investigation Work Plans (SIWPs) will identify data gaps and the approach to filling those data gaps, and field investigation work will collect data to fill the data gaps in accordance with those SIWPs. The schedule is a balance between expediting the work (which includes data analysis and interpretations), the practical amount of time required to execute such activities, and follow WDNR's NR700 process (e.g., prepare/submit SIWPs and SIRs, and allow for associated WDNR review/approval timeframes prior to executing the work). We believe this schedule will allow the data interpretation and additional investigation work to proceed in a relatively rapid manner while also providing adequate time for WDNR to review and approve documents in accordance with the NR700 investigation process.

Tyco and Arcadis look forward to hearing your thoughts on the schedule, and our continuing dialogue with WDNR regarding these activities.

investigation work plan that addresses data gaps identified in the Interim SIR as well as WDNR's Interim SIR comments).

4. The Interim Site Investigation Report - Stanton Street noted on line 28 above may not include a full CSM, as more data will be necessary to complete a PFAS CSM for the Stanton Street site.
