The Wisconsin Department of Natural Resources (DNR) has reviewed the submittal, *Monitoring Well Abandonment Exemption Request for MW043S, TYCO Fire Products LP, Stanton. Street Facility, Marinette Wisconsin* (Exemption Request), dated April 15, 2020, and prepared by Jacobs. The Exemption Request was prepared to address the requirements of Wis. Admin. Code § NR 141.25 - Abandonment Requirements.

The Exemption Request states that during construction activities associated with TYCO Fire Products' lessee's (ChemDesign) new building, MW043S was unable to be located for abandonment. Efforts to locate the well included using coordinates and measurements from existing wells to dig in the area where it was expected to be. Additional efforts including using a metal detector could not be performed as the protective pipe/flush mount well cover had been displaced. No signs of the 2-inch diameter PVC well casing or concrete were observed or recovered. MW043S was a shallow well completed to a depth of approximately 15 feet below ground surface and in the unconfined alluvial aquifer located in the Main Plant area and in the footprint of the new ChemDesign building.

Monitoring wells that have not been properly abandoned in accordance with Wis. Admin. Code § NR 141.25 become part of the administrative record to which continuing obligations are imposed via a DNR remedial action or closure approval. At the time that continuing obligations are to be imposed, the exemption request may be used to document the efforts taken to locate the monitoring wells, as required under Wis. Admin. Code § NR 726.09(2)(h).
