The Wisconsin Department of Natural Resources (DNR) is aware that your well was tested on June 10, 2021, by the National Guard Bureau for the reason of determining the presence or absence of per and poly fluoro-alkyl substances (PFAS) as part of a site investigation related to the Wisconsin Air National Guard 115th Fighter Wing site located at 3110 Mitchell Street in Madison (BRRTS No. 02-13-581254). If you have not already received a copy of these results from the National Guard Bureau by U.S. mail or FedEx, you should receive a copy soon.

The results indicate that your well is impacted by per- and polyfluoroalkyl substances (PFAS). The DNR is issuing this advisory under Wis. Admin. Code § NR 738.03(1) and recommending that the well or water supply not be used for human consumption (i.e., drinking, cooking) at this time due to potential human health risks.

Summary of results

The sample collected from your well was analyzed for PFAS by the National Guard Bureau. As reported to the DNR, the specific PFAS compounds of PFOA and PFOS were detected at a concentration above the Department of Health Services (DHS) recommended groundwater enforcement standards.

Listed below are the sample concentrations and the respective standards which were reported to the DNR:

Note: One milligram per liter (mg/L) is equal to one part per million. One microgram per liter $(\mu g/L)$ is equal to one part per billion. One nanogram per liter (ng/L) is equal to one part per trillion.

Health impacts

When a health-based enforcement standard is attained or exceeded, the DHS recommends that you do not use the water for drinking or preparing beverages or foods that take up a lot of water (e.g., soup, rice, oatmeal). Temporary water

With this advisory, you are eligible to receive a temporary emergency supply of drinking water from the DNR under Wis. Admin Code ch. NR 738. To receive a temporary emergency drinking water supply, you will need to sign the enclosed legal agreement and provide it to the DNR. You may submit the signed agreement to the DNR by emailing or mailing it to the location noted on the agreement.

Please note: Temporary emergency water supplies may only be provided by the DNR for a maximum of six months from the date of this letter, or until such time as the DNR confirms: 1) that well water does not contain contaminants above DHS-recommended enforcement standards; 2) the contaminated water supply has been replaced by an uncontaminated water supply; 3) the private water supply has returned to an uncontaminated condition, whichever occurs first; or 4) another person has taken over responsibility for providing temporary emergency water to your residence. Temporary water is only available to affected parties that are not otherwise considered a "responsible party" under Wis. Stat. ch. 292.
