Dear Carrie,

Thank you for the WDNR's input on the Rhinelander-Oneida County Airport PFAS Work Plan-Area Wide Potable Well Investigation. We appreciate the WDNR's review and comments. This afternoon the RP Team had a chance to discuss your comments along with the coordination process for the actual sampling. The RP Team's response is the [blue text](#) below:

- *Response Actions (Alternative Water Management Plan), p. 5 – Please clarify when bottled water will be provided by the Responsible Parties to the private well owner/user. What would be the timeframe? 1 business day? Longer?*
 - *The RP Team will provide bottled water to those homeowners/well users within one (1) business day of receiving laboratory analytical results indicating proposed PFAS ES exceedances.*
- *Response Actions (Alternative Water Management Plan), p. 5 – Please clarify when a confirmation sample is needed and when bottled water will be provided, before or after the confirmation sample?*
 - *Concerning the question of when confirmation sampling is needed. The RP Team would like to keep the Work Plan response that “A confirmation sample will be scheduled, as needed.” This is based on several reasons including:*
 - *The RP Team understands that there may be times when conducting confirmation sampling after receiving the initial results will make sense and be protective of the public's health. The RP Team is willing to schedule confirmation sampling on a case-by-case basis.*
 - *We anticipate that locations with positive PFAS laboratory results may be placed on a periodic (i.e. quarterly) sampling schedule.*
 - *Due to typically long laboratory TATs (without paying for rush fees), a proposed confirmation sample may occur just before a periodic sampling event.*
 - *If a location has a proposed ES exceedance, it may be more responsive to spend the RP Team's resources to provide bottled water and conduct further sampling on a periodic basis.*
 - *For the scenarios where the initial laboratory results are either just below or well below the proposed ES, again, typical laboratory TATs may have the RP Team receiving laboratory results just before a periodic sampling event. In these cases, the RP Teams resources may best be used by conducting additional sampling during the periodic event.*

- *The RP Team will provide bottled water within one business day of receiving the initial laboratory results indicating proposed PFAS ES exceedances. Providing the bottled water will occur before any confirmation sampling.*
- *Response Actions (Alternative Water Management Plan), p. 5 – Providing bottled water and point of entry treatment are considered to be interim actions. Long term solutions such as the installation of a replacement private well or municipal well should be considered.*
 - *RP Team Response: Understood.*
