

Dear Ms. Haag:

Thank you for your letter of September 28th. Tyco is grateful for your recognition of "the outreach that JCI/Tyco has conducted to date with homeowners," and it is very meaningful to us to see that the WDNR "appreciates [our] efforts to deliver safe drinking water to impacted homeowners in the PWSA."

It is an honor and privilege for Tyco to be engaged so closely with our neighbors. Many of them have remarked that our personal outreach to them is the first time they have felt meaningfully included and the first time they have felt that they could communicate their wishes and have their questions and concerns respectfully addressed. Tyco has been clear that we will do all in our power to honor and respect the wishes of our neighbors and deliver their long-term clean drinking water preferences. We are doing just that.

Tyco is also grateful for the WDNR's support and encouragement to Tyco to continue the progress we've made with our neighbors towards getting their requested deep wells built. Tyco is already at work with homeowners who have provided us their written direction and we will continue to work until winter conditions cause us to pause. We will pick back up and continue the work in the spring.

Having said this, Tyco is perplexed by many other aspects of your letter. Surprisingly, your letter includes many inaccurate statements and inferences as well as requests for action on matters known to already have been completed by Tyco.

Knowing our shared commitment to accurate and helpful communications, we take the occasion here to correct inaccurate assertions and to remind you of actions already taken by Tyco addressing other points raised.

Key Corrections and Clarifications:

You assert that Tyco has said that deep wells are the "only solution for homeowners in the PWSA".

This assertion is inaccurate as evidenced by the following:

- 1. ROAR filed with the WDNR identifying **8 options**. [Sept. 10, 2019]
- 2. Tyco email to WDNR (Christine Haag and Gail Good) sharing Tyco's plan to reach out individually and personally to each well owner in the PWSA re **4 water solution options** [February 24, 2022]
- **3.** Ad placed by Tyco in local papers communicating the **4 water solution options** [February 25, 2022]
- 4. **Fact sheet on each of the 4 options** and notice that Tyco will be calling to answer neighbor questions mailed to residents [March 3, 2022]

- Meeting with the WDNR re the 4 water solution options emerging from facilitated discussions and independent engineering studies commissioned by the Town of Peshtigo and paid for by Tyco [March 3, 2022]
- 6. Email sending WDNR Fact sheet on each of the 4 options [March 3,2022]
- 7. Ad in local papers answering FAQs about **4 options** raised during Outreach [March 23, 2022]
- 8. Ad in local papers updating Tyco outreach on 4 options, included FAQs [April 8, 2022]
- 9. Ad in local papers sharing PWSA Resident Feedback (2 of 4 options preferred by residents) & Next Steps [May 20, 2022]
- 10. Call between Gail Good, Christine Haag and Katie McGinty informing WDNR of the results of neighbor outreach and neighbor's support for **2 of the 4 options**. [May 20, 2022]
- 11. Call with Alyssa Sellwood & Jodi Peotter sharing details of resident outreach and feedback confirming preference for **2 options** [June 2, 2022]
- 12. Tyco ad and mailing to PWSA well owners on their 2 preferred options [August 19, 2022]

You assert: "JCI/Tyco provides only 32 calendar days for homeowners to make this decision".

This assertion is inaccurate as evidenced by the following:

- 1. Plain language in September 15, 2022 cover letter to neighbors accompanying well agreement making clear that October 17th date is only to enable construction before the frost ("Please return signed copies of the enclosed (1) Agreement and Notice of Restrictions, and (2) Well Information Form by no later than October 17, 2022. The sooner we receive your signed documents, the sooner we can begin installing your well, weather permitting.")
- 2. Plain language in September 15, 2022 letter to neighbors accompanying well agreement making clear that the only consequence of a failure to decide about a deep well on/before October 17th is that Tyco will reach out personally to neighbors again. ("Please note that if we do not receive your signed documents by October 17, 2022, we will attempt to contact you via phone or an alternate address if we have that information.")
- 3. Call between Christine Haag, Alyssa Sellwood, Katie McGinty and Denice Nelson where Tyco very clearly explained that Tyco had put forward no such deadline [September 27, 2022]
- 4. Plain language in September 28, 2022 letter to neighbors reiterating that October 17th date is only to enable construction before the frost ("We asked for your responses to us by October 17, so that we could get wells built before the soil freezes.")
- 5. Plain language in September 28, 2022 letter to neighbors reiterating that the only consequence of a failure to decide about a deep well on/before October 17th is that Tyco will reach out personally to neighbors again. ("We asked for your responses to us by October 17, so that we could get wells built before the soil freezes. We also said we would continue to call and reach out to anyone we don't hear from by then and that we were aiming to have everyone's final direction to us in hand by January 15th.")

You request Tyco to communicate to homeowners "the likely presence of radium in groundwater from the deeper aquifer".

The WDNR is aware that Tyco already communicated this information to neighbors as evidenced by the following:

- 1. Phone call with Gail Good, Christine Haag, Alyssa Sellwood and Kyle Burton discussing this communication to neighbors [Sept. 12, 2022]
- 2. Email to Gail Good, Christine Haag, Alyssa Sellwood and Kyle Burton from Katie McGinty confirming this information was communicated to neighbors [Sept. 15, 2022]
- 3. Fact sheet sent to neighbors including information on radium [Sept. 15, 2022]
- 4. Tyco website post Deep Well Agreements Sent to PWSA Residents; *Includes information on how Deep Wells will be constructed & tested* includes copy of communication to neighbors [Sept. 19, 2022]

You state: "The DNR looks forward to hearing from JCI/Tyco as to whether they intend to afford impacted homeowners additional time to review the offer for a deep well".

The WDNR is aware that Tyco already issued public communication waiving the January 15th date since it appeared to create some confusion as evidenced by the following:

- Phone call with Christine Haag and Alyssa Sellwood confirming we were already preparing a letter to those who received the Deep Well agreements waiving the January 15th date [Sept. 27, 2022]
- 2. Follow-up email to Christine Haag and Alyssa Sellwood confirming that the communication about waiving the January 15th date was being made in real time [Sept. 28, 2022]
- 3. Letter mailed to neighbors and posted on tycomarinette.com website waiving the January 15th date [Sept. 28, 2022]

Your letter notes that Tyco shared with the WDNR "that same day" our September 15th letter to neighbors. This suggests that the WDNR was unaware of or surprised by Tyco's action to fulfill neighbor's requests and get to work on the requested deep wells.

The WDNR was well aware that Tyco was moving forward to honor neighbor's wishes for deep wells. An itemization of Tyco's many communications with the WDNR on this matter is attached. We highlight some of the most relevant of those communications here:

- 1. Tyco sent WDNR ad published in local papers about Long-Term Water & Well Agreements that highlights upcoming dates [Aug. 22, 2022]
- 2. Tyco posts notice on website that Deep Well Agreements coming in Sept.; Katie McGinty emails Gail Good and Christine Haag requesting meeting to review next steps of process [Aug. 26, 2022]
- 3. Katie McGinty sends follow-up email to Gail Good and Christine Haag about the meeting requested Aug. 26 that WDNR had not yet responded to [Sept. 2, 2022]
- 4. Tyco has call with WDNR (Gail Good, Christine Haag, Alyssa Sellwood, Kyle Burton) about deep wells discussing next steps [Sept. 12, 2022]

Your letter makes several references to the requirements of NR 700 and suggests that the WDNR has reason to be concerned that Tyco perhaps is not adhering to same. But the WDNR has recognized many times Tyco's faithful and fulsome execution pursuant to NR 700. Tyco is unaware of any of the other known sources of PFAS (paper mills, local landfills, manufacturing plants) that are as far along as Tyco is in complying with NR 700. In fact, it has been surprising that WDNR has not taken more action to stop these continued known sources of PFAS discharge into the environment. Tyco has repeatedly and publicly expressed our appreciation for WDNR's rapid replies to and approval of our many site investigation work

plans and remediation actions pursuant to NR 700. We share a sample of these submissions and WDNR approvals below. Approvals are highlighted in blue.
