This email is in response to Tyco's Request for Alternate Site Specific Grout Mixture Memo, dated May 26, 2023, which proposed replacing the Type II with Type IL Portland cement in the site specific grout mixture previously reviewed in the late 1990s.

Since production of Type I Portland cement has switched to Type IL, emergency rule, DG-07-22(E) went into effect on January 12, 2023, and provides for the use of Type IL cement in the grouting and sealing of wells under Wis. Admin. Code ch. NR 812. Please note that Wis. Admin. Code ch. NR 141, as referenced in the Memo, does not specify the type of Portland cement. The proposed alternate site specific grout mixture is acceptable, replacing the Type II Portland cement with Type IL.
