By this letter/email, and as a follow up to the Conclusions and Recommendations section of K Singh's July 10, 2023 report letter, we are notifying the Wisconsin Department of Natural Resources (WDNR) that vapor mitigation system commissioning testing for the residential section of Community Within the Corridor - West Block (Buildings 6, 7, 8A, and 8B) has been completed in accordance with the WDNR's letter dated May 23, 2022, approving CWC's Commissioning Plan for the West Block. More particularly, the following three consecutive rounds of commissioning testing showed no exceedances of TCE in indoor air above the 2.1 µg/m<sup>3</sup> vapor action level (VAL):

1. Commissioning testing conducted December 2022 in accordance with the commissioning plan approved by WDNR on May 23, 2022, the results of which are summarized in a report dated December 28, 2022.
2. Commissioning testing conducted February 2023 in accordance with the commissioning plan submitted to WDNR on February 17, 2023, the results of which are summarized in a report dated April 5, 2023.
3. Commissioning testing conducted June 2023 in accordance with the revised commissioning plan approved by WDNR on May 30, 2023, the results of which are summarized in a report dated July 10, 2023.

As such, CWC does not plan to conduct additional vapor mitigation system commissioning testing on buildings 6, 7, 8a, 8b. At this time, we will continue to focus on completing commissioning testing for Buildings 4 and 5, in addition to turning our attention to the next steps for buildings 6, 7, 8A, and 8B under the May 23, 2022, and May 30, 2023 approval letters.
