Hello Mike,

Thanks for reaching out. Though PFAS standards have not been codified, PFAS meet the definition of a hazardous substance and are subject to regulation under Wisconsin Statutes ch. 292 and the requirements for investigation and remediation in Wisconsin Administrative Code chapters NR 700-799. The second round of groundwater samples confirmed an exceedance of the Wisconsin Department of Health proposed combined groundwater standard at SB-1R, SBGW-3R, and SB-14R. Initial soil sampling showed the presence of PAS in soil at SB-8R indicting the possibility of a PFAS source of the site.

The next step for the site is defining the extent of PFAS contamination in groundwater. This will likely require installation of off-site monitoring wells. The DNR can review a proposed work plan once it has been completed, if that would be helpful, please submit a technical assistance request with the work plan.


