Dear Mr. Neal:

The information provided herein is a summary of activities conducted at the Tyco Fire Products LP (Tyco) site associated with the Pump Down Program for the former Salt Vault and 8<sup>th</sup> Street Slip areas. The Pump Down Program is required as part of the Administrative Order on Consent between Tyco and U.S. Environmental Protection Agency (USEPA). This summary report covers the period from October 14, 2017 through November 3, 2017.

## **Summary of Work during Reporting Period**

Work conducted during the reporting period included:

- Pumping operations ceased on October 9, 2017; therefore, no additional groundwater was removed from the Pump Down area during the reporting period.
- Manual water level readings at the designated monitoring points and extraction wells have been collected during the interim shut down period. The manual water level readings and corrected elevations table is attached.
- The temporary pump down system was decommissioned for the winter period on November 1, 2017. This included emptying and removing the conveyance pipes, removal of the pumps, and cleaning the secondary containment structure and partially disassembling the structure so that rain and snowmelt will not collect in the structure during the interim shut down period.

 Off-site transportation of recovered groundwater was completed during the reporting period.

A summary of pumping and disposal operations for 2017 is provided in Table 1.

Long-term management alternatives of the groundwater in the Pump Down area will continue to be evaluated during the interim shut down period.

# **Anticipated Work During Interim Shut Down Period**

Manual water levels will be collected from the designated monitoring wells on a monthly basis during the interim shut down period. Groundwater elevation data will be provided monthly during the interim shut down period.
