**Rules, Regulations and Information**

1. **Reservations:** The Wyalusing indoor group camp may be reserved up to one (1) year in advance before the date the site is to be occupied. If the reservation is for a weekend night, it must be for at least two nights. Calling the park prior to making a reservation request is suggested to determine availability. Contact the Wyalusing State Park office at 608-996-2261.
  - a. Reservation requests must be made by mail or in person. Mailed applications must arrive at the park office not less than 7 days before the date the site is to be occupied.
2. **Availability:** April 1 through October 31.
3. **Camping Fees:** \$6/person/night (\$300/group/night minimum) plus \$7.75 reservation fee.
4. **Sleeping Accommodations:** Four separate buildings, each accommodating 27 people (108 people total). Bunk beds with mattresses. Indoor showers and flush toilets. Buildings are heated.
5. **Eating Accommodations:** Eating facilities are in a separate building, which also serves as a meeting area/recreation hall. The kitchen and eating facilities are modern.
6. **Check-in:** A department staff person will admit your group into the camp. Please report to the park office upon arrival at the park.
7. **Check-out time:** A camping day runs from 3:00 p.m. to 3:00 p.m. the following day.
8. **Pets:** Pets are not allowed in the buildings at any indoor group camp. At the Wyalusing Indoor Group Camps, pets are not allowed on the grounds.
9. **Fires:** Fires are permitted only in designated fire rings or grills. Please note there are restrictions for moving firewood.
10. **Other Camping Units:** Camping in tents or other camping units is not permitted at the Wyalusing Indoor Group Camp.
11. **Adult Leaders:** One adult leader is required for every ten (10) juveniles.
12. **Park Stickers:** Vehicle admission stickers are required on all vehicles at the park, in addition to camping fees. *Fees are subject to change.*

13. **Refund conditions:**
  - a. The camping fee, minus the reservation fee, is refundable if the cancellation request is received 30 days prior to the reservation start date.
  - b. The camping fee, minus the reservation fee and one night's camping fee, is refundable if the cancellation is received less than 30 days after the reservation start date.
