Notice: This No Exposure Certification form is authorized by s. NR 216.21(3), Wis. Adm. Code. Submittal of this form is required for industries listed within subchapter II of ch. NR 216, Wis. Adm. Code, where the facility has no exposure of materials or operations that could contaminate storm water. This certification must be submitted to the Department every five years. Failure to properly submit a completed No Exposure Certification to the Department every five years may result in forfeitures up to \$10,000 per day, pursuant to s. 283.91(2), Wis. Stats. Personally identifiable information on this form may be used for other water quality program purposes.

Submission of this No Exposure Certification constitutes notice that the entity identified in Section I does not require permit authorization for its storm water discharges associated with industrial activity under subch. II of ch. NR 216, Wis. Adm. Code, due to the existence of a condition of "no exposure."

A condition of "no exposure" exists at an industrial facility when all industrial materials and activities are protected by a storm resistant shelter to prevent exposure to rain, snow, snowmelt, and/or runoff. Industrial materials or activities include, but are not limited to, material handling equipment or activities, industrial machinery, raw materials, intermediate products, by-products, final products, or waste products. Material handling activities include the storage, loading and unloading, transportation, or conveyance of any raw material, intermediate product, final product or waste product. A storm resistant shelter is not required for the following industrial materials and activities:

- Drums, barrels, tanks, and similar containers that are tightly sealed, provided those containers are not deteriorated and do not leak. "Sealed" means banded or otherwise secured and without operational taps or valves.
- Adequately maintained vehicles used in material handling.
- Final products, other than products that would be mobilized in storm water discharges (e.g., rock salt).

A No Exposure Certification must be provided for each facility applying for the no exposure exclusion. In addition, the exclusion from WPDES permitting is available on a facility-wide basis only, not for individual outfalls. If any industrial activities or materials are or will be exposed to precipitation, the facility is not eligible for the no exposure exclusion.

By signing and submitting this No Exposure Certification form, the entity in Section 1 is certifying that a condition of "no exposure" exists at its facility or site, and is obligated to comply with the terms and conditions of s. NR 216.21(3), Wis. Adm. Code.

All information must be provided on this form. Detailed instructions for completing this form and obtaining the no exposure exclusion are provided on pages 3-4. Please read the instructions prior to completely filling out this form.

This form must be signed by an official representative of the permitted facility, in accordance with s. NR 216.22(7), Wis. Adm. Code. See instructions on page 4. If this form is not signed, or is found to be incomplete, it will be returned.

No Exposure Certification for Exclusion from WPDES Industrial Storm Water Permitting:

I certify under penalty of law that I have read and understand the eligibility requirements for claiming a condition of "no exposure" and obtaining an exclusion from WPDES storm water permitting.

I certify under penalty of law that there are no discharges of storm water contaminated by exposure to industrial activities or materials from the industrial facility or site identified in this document (except as allowed under s. NR 216.21(3)(c), Wis. Adm. Code).

I understand that I am obligated to submit a No Exposure Certification form once every five years to the Department and, if requested, to the operator of the local municipal separate storm sewer system (MS4) into which the facility discharges.

I understand that I must allow the Department, and MS4 operator where the discharge is into the local MS4, to perform inspections to confirm the condition of "no exposure" and to make such inspection reports publicly available upon request.

I understand that I must obtain coverage under a WPDES permit prior to any point source discharge of storm water from the facility. Additionally, I certify under penalty of law that this document and all attachments were prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gathered and evaluated the information submitted. Based on my inquiry of the person or persons who manage the system, or those persons directly responsible for gathering the information, the information submitted is to the best of my knowledge and belief true, accurate and complete.

I am aware that there are significant penalties for submitting false information, including the possibility of fine and imprisonment for knowing violations.

Instructions

Who May File a No Exposure Certification

Wisconsin law under subch. II of ch. NR 216, Wis. Adm. Code, prohibits point source discharges of storm water associated with industrial activity to waters of the State without a Wisconsin Pollutant Discharge Elimination System (WPDES) permit. However, WPDES permit coverage is not required for discharges of storm water associated with industrial activities if the discharger can certify that a condition of "no exposure" exists at the industrial facility or site. Storm water discharges from construction activities identified in subch. III of NR ch. 216, Wis. Adm. Code, are not eligible for the no exposure exclusion.

Obtaining and Maintaining the No Exposure Exclusion

This form is used to certify that a condition of "no exposure" exists at the industrial facility or site described herein. This certification must be re-submitted once every five years. The industrial facility operator must maintain a condition of "no exposure" at the facility or site in order for the no exposure exclusion to remain applicable. A facility that has submitted a No Exposure Certification form should routinely inspect the facility to verify that it continues to operate in a condition of "no exposure."

If conditions change resulting in the exposure of materials and activities to storm water, the facility operator must obtain coverage under a WPDES storm water permit immediately. Any conditionally exempt discharger who anticipates changes in circumstances shall submit a Notice of Intent form to the Department 14 or more working days prior to the change of circumstances and in accordance with s. NR 216.22, Wis. Adm. Code.

Completing the Form

You must type or clearly print your answers to all questions. One No Exposure Certification form must be completed for each facility or site for which you are seeking to certify a condition of "no exposure". Please make sure you have addressed all applicable questions and have made a photocopy for your records before sending the completed form to the Department.

Section I. Facility/Operator Contact Information

1. Provide the legal name of the business that operates the facility or site described in this certification.
2. The operator is the legal entity that controls the facility's operation, rather than the plant or site manager. Provide the name of the person who will be the contact for the operator.
3. Provide the contact information for the operator contact.
4. Provide the mailing address for the operator contact. All correspondence will be sent to this address.

Section II. Facility/Site Location Information

1. Enter the official or legal name of the facility or site, the county, and municipality name.
2. Enter the location address, if no address exists, provide a geographic description.
3. Enter the geographical description of the approximate center of the facility or site in Public Land Survey System (PLSS) format with township, range, section, quarter, and quarter-quarter information.
Note: This information can be found on property tax statements, plat maps, Wisconsin Atlas and Gazetteer, and online with Wisconsin DNR Surface Water Data Viewer at: <http://dnrmaps.wi.gov/sl/?Viewer=SWDV>
4. Enter the Latitude and Longitude in decimal degrees.
5. Enter the total acres of the site associated with industrial activity.
6. Indicate whether the facility is located on Indian Lands.
7. Indicate whether the industrial facility is operated by a department or agency of the Federal Government (see also Section 313 of the Clean Water Act).
8. Indicate whether the facility was previously covered under a WPDES storm water permit.
If yes, include the Facility ID Number (FID) and/or FIN.
Enter the 4-digit SIC code which identifies the facility's primary activity and second 4-digit SIC code identifying the facility's secondary activity, if applicable. SIC codes can be obtained from: https://www.osha.gov/pls/imis/sic_manual.html
9. Indicate whether a formerly exposed, pervious area (i.e., lawn, meadow, dirt or gravel road/parking lot) has been paved or roofed over in order to qualify for no exposure.
If yes, indicate approximately how much area was paved or roofed over.
10. Required: attaching photos that are representative of the current outdoor conditions may eliminate the need for an inspection and facilitate a more timely acknowledgment by the Department. Provide the date the photos were taken.

Section III. Exposure Checklist

Check "Yes" or "No" as appropriate to describe the exposure conditions at your facility. If you answer "Yes" to ANY of the questions in this section, a potential for exposure exists at your site and you cannot certify to a condition of "no exposure". You must obtain coverage under a WPDES storm water permit if you have not already done so. After obtaining permit coverage, you can institute modifications to eliminate the potential for a discharge of storm water exposed to industrial activity, and then certify to a condition of "no exposure."

Section IV. Certification & Signature

Wisconsin statutes provide severe penalties for submitting false information on this application form. State regulations require this application to be signed in accordance with the signatory requirements of s. NR 216.22 (7), Wis. Adm. Code:

1. For a corporation: a responsible corporate officer including president, secretary, treasurer, vice president, manager, or a duly authorized representative having overall responsibility for the operation covered by this permit
2. For a unit of government: a ranking elected official, or other duly authorized representative
3. For a partnership: a general partner; and for a sole proprietorship: the proprietor
4. For a limited liability company: a manager
