(a) Persons subject to or entered into such orders, agreements or processes shall pay fees for services provided by the department, under ch. NR 749 or 750.

(b) Immediate actions associated with emergency spill cleanup activities, including department signoff on the Notification for Hazardous Substance Discharge form, do not require a review fee.

(c) An "Other technical assistance fee" is required if a person requests a meeting of the department to discuss specific technical issues at a property or site, in accordance with s. 292.55, Stats. This does not include meetings of a general nature, including "Green Team" meetings with local governments, for example.
