**Rule Information:** This rule package establishes standards for the implementation of an off-highway motorcycle (OHM) program, including safety, enforcement, and trail grant programs. This rule defines OHM terms not included in s. 23.335 (1), Stats., creates a purpose section, clarifies registration and trail pass procedures, and contains other administrative procedures needed for implementation.
