

Notice: This form is to apply to be recommended to the Governor's office for appointment to the State Trails Council (STC), or to join the STC in a non-voting position. Appointments to the STC for voting positions are made by the Governor's office. Personal information collected will be used for administrative purposes and may be provided to requesters to the extent required by Wisconsin's Open Records Law (ss. 19.31-19.39, Wis. Stats.).

The State Trails Council was created by state statute 15.347(16) in 1989. Council members appointed by the governor to four-year terms, must be knowledgeable in various recreational uses of trails. Additional members may serve on the STC as non-voting members to help ensure representation of a wide variety of trail users.

The STC provides advice and consultation to the Department of Natural Resources (DNR) on the planning, acquisition, development, and management of trails in Wisconsin. The council represents trail users in Wisconsin, which includes more than half of the state's residents. The council is also responsible for providing counsel in administering Federal Recreational Trails Program (RTP) funds. The STC serves as Wisconsin's state recreational trail advisory committee for RTP, necessary for Wisconsin to participate in the program.
