**Original:** Boat has not been registered in Wisconsin previously. Upon completion of an Original registration DNR will provide a certificate of number and title (if required) and expiration decals. Registration numbers are assigned but are NOT provided. \*Includes \$5.00 titling fee if applicable.

**Transfer:** Boat has been registered in Wisconsin previously with a Wisconsin Registration Number and decals are current or expired (if expired, also add the fee for renewal). Upon completion of a transfer or transfer/renewal registration DNR will provide a certificate of number and title (if required) and expiration decals if applicable.

**Renewal:** Boat registered IN YOUR NAME in Wisconsin. Upon completion of a Renewal registration DNR will provide a certificate of number and expiration decals. Registration numbers are assigned but are NOT provided.
