Rule Information:

Board Order WM-21-18 is a permanent rule that would modify chs. NR 10 and 45 related to hunting, trapping and target shooting. This rule will serve several purposes, including simplifying weapons restriction regulations, offering additional trapping opportunities, and provide regulated shooting in Rock County.
