Project Description Summary

The Polar Snowmobile Club has lost permission for a section of trail across private land necessitating a reroute. The reroute described below will be 0.2 miles longer than the current trail and will require some development. See Appendix B for details about development of the trail.

This trail is both snowmobile and winter ATV. Development request is to be split 50/50 between snowmobile and ATV. The new maintenance for the additional 0.2 miles is split \$60.00 Snowmobile and \$20.00 ATV.

Langlade County winter ATV trails open 10 days after snowmobile trails open and only when the temperature is below 28 degrees.

Trail Project Detailed Description
Due to loss of permission on private lands the snowmobile trail will need to be rerouted around a section of private property. The current trail that would be removed from the trail system is 0.6 miles and the reroute is 0.8 miles. The proposed reroute runs through agricultural fields and fallow fields and farm roads to the greatest extent possible to minimize trail construction and reroute costs. Several sections will require brushing, mowing and signing only. New trail will be constructed through a small wood lot creating a new section about 400' long to complete the reroute. The total area to be disturbed will be less than 1/5 acre and will involve tree removal, grubbing of stumps and shaping and grading of the trail base. A contractor will complete the grubbing of stumps and construction of the new trail and the snowmobile club will complete all other work.

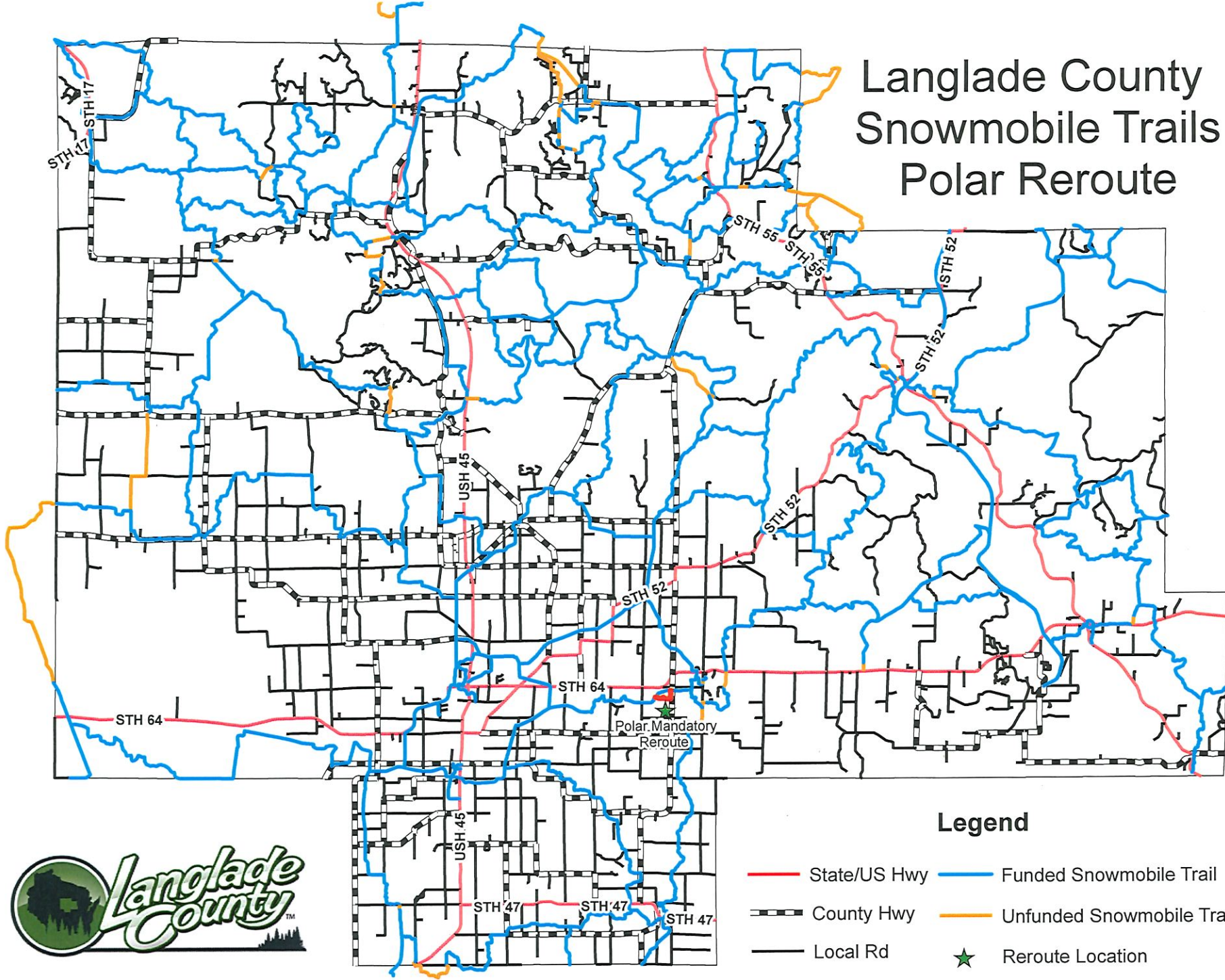

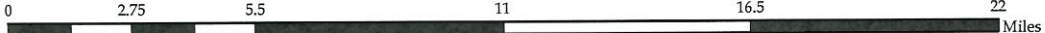

Langlade County Snowmobile Trails Polar Reroute

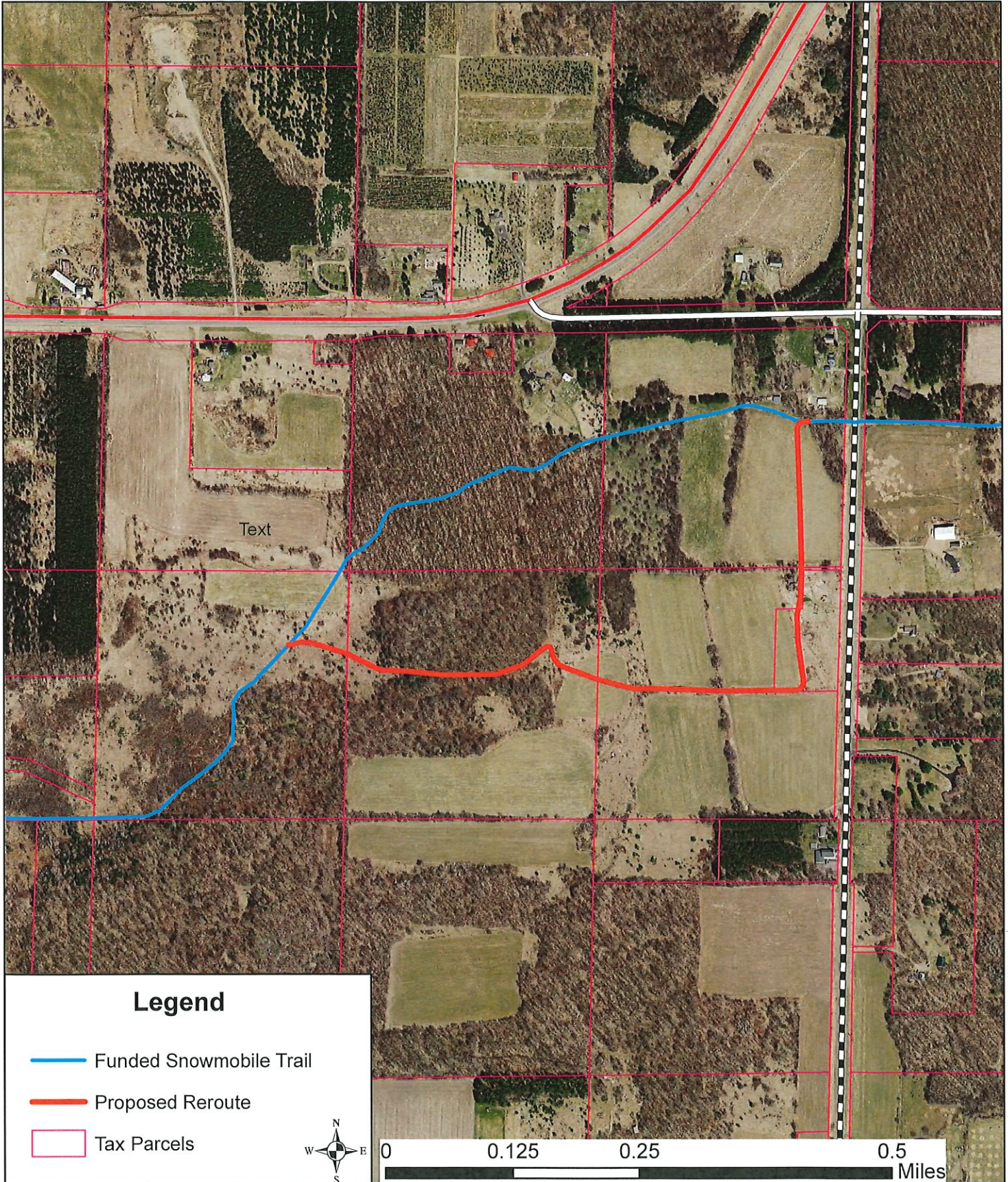
