4. Public Comments

 Tara Krall – Iron County. The draft ranking tools do not utilize the mean snowfall points that the New Miles tools use. Any consideration to adding them to the bridge and reroute drafts?

5. Information & Action: Review of Bridge Ranking Tool Recommendations of the Ad Hoc Committee

- An ad hoc committee was formed and met Nov 30th. The members of the ad hoc included Dale Mayo, Bob Lang, Gary Hilgendorf, Sue Smedegard, Eric Rady (Oneida Co), and Susan Tollander (Burnett Co). The 2018 version of the of the Bridge Ranking Tool was reviewed and discussed, and new questions and points suggested.
- Suggestion to add the phrase "certified bridge inspector" to Question 1. Would culverts need an inspection
 report to earn these points? (Yes, if inside diameter greater than 24 inches. If less than, the project is trail
 rehab not bridge rehab). Copy of the report would need to be included to earn these points. Would the
 inspection report need to be within a certain date? Not really, if the inspection report identified problems
 and they were never addressed, then they still need to be addressed.
- County coordinators should reach out to their highway departments to coordinate bridge inspections.
 Highway bridges must be inspected regularly, and it's very effective to roll recreation bridges into the mix.
 Can space them out so they aren't all inspected in one year, and can use maintenance funds for the inspection. Multiple counties report an expense of approx. \$350 to \$500 per bridge inspection.
 Recommend inspections every 4-5 years to ensure structure is safe and repairs happen promptly.

Comment from Dave Kafura that, if replacing a bridge in kind, permit not needed/already issued. WMS's
don't have time to provide initial comments. Suggest by Bob Lang (?) to add points for 'permit in hand' to
cover those already permitted/replacement-in-kind.

Motion to recommend to the full Council the amended bridge ranking tool. Motion by Dale and 2nd by Andy. MOTION PASSED

- 6. Information & Action: Review of Reroute Ranking Tool Recommendations of the DNR
 - DNR staff reviewed the 2017 relocation/reroute ranking tool and drafted revisions that mirrored the bridge ranking tool where appropriate, and also gave priority points to maintenance-only requests, and highway rec wings, as these have been high priorities of the Council in the past.

Motion to recommend to the full Council adopting the proposed changes to the reroute ranking tool. Motion by Andy and 2nd by Dale. MOTION PASSED



If this bridge is closed due to unsafe conditions, how far around would riders need to travel?

In the example below, to bypass the bridge in question, riders would need to travel 5.73 miles on a trail to the NW.

5) Example of Intersection to Intersection Measurement

If this trail is closed and a relocation not funded, how far around would riders need to travel on existing trails?

In the example below, to bypass the trail segment that is closing, riders would need to travel 5.73 miles on a trail to the NW if the reroute is not approved.
