7. Discussion: Grooming On Road Routes

At an <u>ad hoc committee meeting in April</u>, said group discussed the possibility of paying groomers 50% of the assigned groomer rate (as non-grooming transport time) when they are traveling down a road route that is an integral part of a single funded trail.

The committee intended to bring this up at the August meetings, but failed to do so.

Motion to recommend groomer time gets paid as non-grooming transport time when the groomer is traveling on a route that is an integral part of a single funded trail, at a rate of 50% of the assigned groomer rate by Andy...no 2^{nd} due to discussion items below. MOTION FAILED

In order to implement this, Groomer Tracking Systems and DNR would need to be able to individually identify and manually code the GIS for each road that is "integral to a single funded trail". Going to be a lot of manual work. Given the roll out of GPS units to all groomers this winter, and the timing of the snow season, it is not feasible to implement this by the 21-22 snow season. DNR recommends GTS and DNR review the logistics of this over the winter/spring, and we bring the topic back up in future.
