

Market Rate Unchanged at 2.700%

For the period October 1, 2021 through December 31, 2021, the Wisconsin Department of Administration has set the EIF market rate for loans that have a final maturity:

- of 20 years or less at 2.700%.
- greater than 20 years but less than or equal to 30 years at 2.90%.

The rate applied to each loan is a percentage of the market rate in effect at the time of the municipal meeting at which resolutions approving municipal obligations are passed and bond-related documents and Financial Assistance Agreements are signed/executed.
